##### **1.1 Invitation for bidding**

**Online e-Tenders (online open tenders)** are invited under Two-Bid system (Technical & Financial Bid) are invited by Delhi Institute of Tool Engineering (DITE), Wazirpur Ind. Area, Delhi-110052, through e-procurement from reputed DVAT registered manufacturers, authorized distributors or authorised dealers for “**Supply, Installation & Commissioning of Equipment & Benches for Applied Physics Laboratory**” to the stores at DITE camps-I, Wazirpur, Delhi-110052 on the basis of free delivery at site, as per the schedule of requirements and technical specifications mentioned at **Annexure-6**, within a period of **45 days** from the date of issue of Purchase Order with the terms and conditions in this tender.

**1.3 The estimated cost** of the goods/work/service is **Rs. 10,00,000/-** only.

**EMD of Rs.50,000/-** (Fifty thousand only) in the form of DD/BC/FDR should be submitted as bid security before due date & time or valid exemption certificate issued by NSIC. **EMD exemption is allowed Item-wise only.**

**Bidders seeking EMD exemption for Supply of Items shall be allowed exemption for Supply of those items only which are mentioned in their NSIC exemption certificate under the head “Store Details” for which Quantitative Capacity should be clearly mentioned by the NSIC in terms of number of units or quantity of units which the company is eligible to supply during a specified period (which is generally per month).**

**1.5 The validity** of bid should be 180 days from the due date of tender.
