1.1 Invitation for bidding

e-Tender (online open tenders) under two bid system (Technical & Financial Bid) through e-Procurement from reputed DVAT registered Contractors / service providers are invited, by Delhi Institute of Tool Engineering (DITE), Wazirpur Ind. Area, Delhi-110052 for “**Repair of Grinding Machines**” at DITE campus-II, Okhla Industrial Area Phase-II, Delhi-110020 on the basis of free delivery at site, as per the schedule of requirements and technical specifications mentioned at **Annexure-5**, within a period of **60 days** from the date of issue of Work order with the terms and conditions in this tender.

1.3 The estimated cost of the work/service is Rs. 3,92,500/- only for all the Machines. EMD exemption is allowed Item-wise only.

Bidders seeking EMD exemption for providing Service(s) shall be allowed exemption for those Services only, which are mentioned in their NSIC exemption certificate under the head "Store Details" and for which Quantitative Capacity should be clearly mentioned by the NSIC in terms of value or amount of Rupees of Services that the company is eligible to render during a specified period.

1.4 EMD of Rs 7850/-, in the form of DD/BC/FDR should be submitted as bid security before due date & time or valid exemption certificate issued by NSIC.

1.5 The validity of bid should be 180 days from the due date of tender.
